How Using Facebook and Other Social Media Can Affect Your Personal Injury Case

hen you make a claim or file a lawsuit for compensation for your accident injuries, be aware that your public postings on Facebook, Twitter and other social media sites may be viewed by the insurance company or the attorney for the defendant. This is done through "Electronic Discovery" or "e-discovery," and it is becoming more common every year. In New York State, the law is clear: when you claim an injury,

you are placing your physical condition "in controversy." The insurance company for the defendant will try to prove that your injuries are not as serious as you claim they are. For example, if you testify that because of your injuries you can no longer play sports or do other activities yet you have posted online photographs of yourself playing sports, on vacation or just living an "active lifestyle," a judge
