Answers To Questions About Slip and Fall Accidents

any people who have been in a slip and fall accident call our law firm with questions. Here are answers to some of the most often-asked ones.

Q. What is a slip and fall claim?

A. It's a type of personal injury claim based on premises liability. In personal injury law, a claim based on premises liability generally refers to an injury caused by an unsafe condition on someone's property. Although a 'slip and fall' injury can be caused by a number

of unsafe circumstances, some common conditions that can lead to a slip and fall include defective staircases, accumulations of ice and snow, wet or oily floors, hidden extension cords, loose rugs or carpets, broken or loose flooring, sidewalks, steps, or stairs.

Q. What does a slip and fall claim require?

A. To win a slip and fall claim, you generally must prove several things. You must show you were on the property because you live there, the

After An Accident: Where Will Your Case Be Filed?

n which court will your case be filed? Many people think their case will be brought in Manhattan, because that is where we have our office. Or, you might think the choice is based on where the accident happened. Neither is correct.

As your attorney, one of the important choices we make for you is the court where we file your lawsuit. This is called the "Venue" of your case. New York law requires the case to be "venued" in the county where either the Plaintiff (the injured party) or the defendant (the person who

premises are open to the public, you were invited on the property, or had other reasons to be on the property. Secondly, you must show the property owner was negligent in creating or dealing with an unsafe condition. This means the owner knew or should have known about the unsafe condition but did not address it either by fixing it or providing adequate warnings about it. Third, you must show your injury resulted from the owner's negligence in not addressing the unsafe condition.

For example, during winter, a common example of negligent maintenance comes after an owner fails to adequately remove snow and ice from the sidewalk near their property. After a snowfall, property owners/building managers are responsible to clear the snow and provide pedestrians with a safe walkway.

Have you been injured?

If you or a loved one have been injured due to an unsafe condition on someone else's property, you may be entitled to compensation for your medical bills, lost wages, and other damages.
